# <u>Description of the actions that NOVA School of Law has taken to support the Global Compact</u>

#### 1. Supporting the UN Global Compact through our teaching and research activities

NOVA School of Law is committed to the implementation of the 10 Principles of the UN Global Compact and, more generally, to contribute to sustainability and the realization of the UN Sustainable Development Goals through our teaching and research activities which strive to promote inclusive and equitable quality education (SDG 4). Particular emphasis is placed on areas such as human rights and fundamental rights (UN Global Compact, Principles 1-2) - which include issues of equality and non-discrimination (SDGs 5 and 10), labour rights (UN Global Compact, Principles 3-6) and decent work (SDG 8), – the protection of the environment (UN Global Compact, Principles 7-9 and SDG 15), which include the protection of the oceans (SDG 14) and the fight against climate change (SDG 13), and more generally how to foster responsible consumption and production (SDG 12) and the promotion of peace, justice and strong institutions (SDG 16).

#### 2.2. Our research

Our research activities are supported by the various <u>Knowledge Centres</u> that we have created in order to provide and disseminate impactful research contributing to all three dimensions of sustainable development: the social, the economic and the environmental dimensions. The work of the following Knowledge Centres, *inter alia*, is particularly relevant to the implementations of the 10 Principles of the UN Global Compact organized around its 4 pillars:

Government in the development of its first National Action Plan on Business and Human Rights in 2023 and 2024. At the European level, the Director of the NOVA BHRE co-authored a study led by the British Institute of International and Comparative Law (BIICL) for the European Commission on Due Diligence Requirements in Supply Chains, which formed the basis for the Corporate Sustainability Due Diligence Directive adopted in 2024.

Secondly, it has developed awareness-raising and capacity-building activities aimed at promoting responsible and sustainable corporate conduct. The NOVA BHRE coordinated, together with the NOVA Green Lab, an online specialized course on ESG and Due Diligence in Portugal. The NOVA BHRE also conducted Human Rights Due Diligence training courses in Mozambique (in Portuguese) and in Tunisia (in French) to hundreds of companies of varying sizes and industries as well as government officials under a UNDP-coordinated programme.

These activities have **supported businesses**, **civil society organisations**, **and government representatives** in gaining a comprehensive understanding of the legislative landscape on corporate sustainability but also on the challenges and opportunities of the practical implementation of human rights and environmental due diligence in corporate practices.

Finally, the NOVA BHRE serves as a platform for exchange, fostering regular engagement through research projects, publications, and events with a broad range of stakeholders, including businesses, non-governmental organisations, government agencies as well as European and international institutions.



The NOVA ASCHOOL AW Refugee and Migration Clinic	The NOVA Refugee and Migration Clinic, coordinated by Professor Veronica Cocodel, supports vulnerable populations by fostering critical dialogue on migration studies and policy.  It is dedicated to clinical research and other impact-oriented activities in the areas of migration and asylum, aiming to contribute to a better understanding and respect of the human rights of migrants, asylum seekers and refugees.  It relies on the active involvement of faculty, students, lawyers and civil society actors in research projects, the publication of blog posts and reports, advocacy campaigns and support activities related to these rights.  The NOVA Refugee and Migration Clinic is notably involved in a project with the Conselho Português para os Refugiados [Portuguese Council for Refugees] within which the NGO defines priority topics for reports to be drafted and coauthored with students in relation to the fundamental rights challenges of the New Pact on Migration and Asylum. The project is supported by the European Commission under the Jean Monnet Module scheme awarded to Professor Veronica Corcodel in 2024 on 'Key fundamental rights issues in the EU'. In particular, the Lab considers the main aspects that can help to understand the future of conflict related to the possibilities of creating conditions for peace by promoting the respect for human rights, democracy and the rule of law. In this regard, it also contributes to SDG 16 Peace, Justice and Strong Institutions by analysing accountability mechanisms for human rights violations committed during armed conflict and post-conflict situations.		
	The NOVA Knowledge Centre for Data-Driven Law (DDL Centre) coordinated by Professor Margarida Lima Rego and Fabrizio Esposito promotes the United Nations Sustainable Development Goal 16, dedicated to Peace, Justice and Strong Institutions (SDG16), through the involvement of legal experts in multidisciplinary research teams aimed at collecting and analyzing data, relying on the collaboration of colleagues with training in data analytics, economics and social sciences, among others.  More broadly, DDL supports, produces and stimulates the search for data-driven responses to the most pressing societal challenges of the 21st Century, in order to provide better and more accurate diagnosis of law reform needs; redesign and adjust existing legal instruments; and measure the impact of public policy decisions.  To this end, DDL Centre:  i) organizes seminars, conferences and offers dedicated training aimed at spreading data-driven research in the NOVA School of Law research community;  ii) establishes collaboration outside the NOVA School of Law, inside but also outside Universidade NOVA de Lisboa; and iii) seeks public and private funding to support, produce and stimulate data-driven legal research. Research was also done regarding Personalised Pricing and "Semi-automated Systematic Literature Reviews and Legal Studies, with a focus on Mapping Court Summons Patterns.  Regarding EU Law, there was a research focus on Digital Vulnerability and Hyper-Development Mechanisms and the Draft Regulation on the Safety of Toys. The centre is performing systematic literature reviews on digital vulnerability and dark patterns. The results on the research projects on price personalization and the average consumers will be published in a Cambridge University Press handbook and in a special issue of the European Review of Contract Law, respectively. Members are contributing to the benchmarking of the results of an LLM model specific for legal research. The centre also collaborated on various events, such as the international conference Digital Vulnerability and EU Private Law; and the II International Conference of the Jean Monnet Module on EU Insurance Law: Challenges in the SDG Era, both in July. On 21 November, DDL Centre also made an appearance on the NOVA Science & Innovation Day. In December, the centre contributed to the organization of the Digital Rights Festival, a community-led effort which took place in Cascais. With the support of the centre, the e-course Insurance and Sustainable Development Goals was converted into a MOOC and was made available in the NAU platform from November 2023 to July 2024. It was attended by 726 people.



In doing so, the NOVA IPSI proactively promotes the study, scientific analysis and dialogue, public awareness and strategic collaborations on, among others, the domain of Human Rights of Protection of Moral and Economic Interests of creators and inventors as well as Cultural, Artistic, and Scientific Participation and Enjoyment. The NOVA Green Lab	The NOVA Green Lab, coordinated by Professor Lucila de Almeida, is a knowledge centre founded in 2019 as part of the CEDIS (Centre for Research on Law and Society), the research centre of NOVA School of Law. Since October 2022, it has been coordinated by the Abreu Chair in ESG Impact, Professor Lucila de Almeida.  The NOVA Green Lab aims to promote legal and multidisciplinary research in the field of environmental, climate, and energy law, with a particular focus on the challenges to the implementation of the European Green Deal in Portugal, the European Union, and its global reach. Besides encouraging intensive scholarly debate, the knowledge centre aims to facilitate access of policymakers, civil society, stakeholders, and citizens of different generations to the knowledge needed to achieve a better and more sustainable future.  By pursuing the goals for research, education and dissemination, NOVA Green Lab proactively supports all the objectives set by the United Nations Sustainable Development Goals and, in particular, SDG 13 (climate action), SDG 7 (affordable and clean energy), and SDG 11 (sustainable cities and communities), SDG 12 (responsible consumption and production), and SDG 15 (life on land). the NOVA School of Law's Centre for Research & Development on Law and Society (CEDIS).

Directly anchored in the 4th pillar of the UN Global Compact: Anticorruption, the centre's mission is to develop knowledge to better diagnose the institutional and operational failures that favour corruption and other undesirable conduct, along with the analysis of effective measures to prevent it.

The Centre is a partner in the 'WiS-H: A Whistleblowing Habitat in Southern Europe' project, funded by the European Commission's CERV-2023-CHAR-LITI Programme and coordinated by the <u>Hay Derecho Foundation</u>, with the <u>Universidad De Murcia</u> and the <u>Agencia de Prevención y Lucha contra el Fraude y la Corrupción de la Comunitat Valenciana</u> as partners. The aim is to foster an environment favourable to the protection of whistleblowers in the Iberian Peninsula, through enhancing reporting channels, sharing best practices, and raising awareness about protection measures.

As well as research, it also organises training activities, lectures and workshops, among others. Amongst the important ones that took place in 2023 and 2024 are as follows:

Furthermore, NCL published "The Internationalization of Compliance" in BOW 32 - Portugal Business on the Way (AEP - Portuguese Business Association), by Julia Gracia (NCL) and was featured on CNN Portugal, on December 11th, discussing corruption-related topics.

NOVA Tax Research Lab	NOVA Tax Research Lab coordinated by Professor Rita Calçada Pires, was created in the second half of 2021, aiming to develop activities related to Tax Law, including its International and European perspectives. Namely, the Knowledge Centre's aims to provide scientific research, training, promote tax citizenship and tax education. It is also intended at preparing studies and opinions, developing editorial activities, providing digital content and support to taxpayers (Article 1 number 2 of its by-laws).  Amongst its key projects are the following ones:  1. TAX EDUCATION PROJECT The project started with the first goal of the Knowledge Centre in mind: contribute to the development and understanding of Tax Law. Thus, the Tax Education Project was the central project for the start-up of the activity. Within the scope of the Tax Education Project, the option was to initially target the young national public, through the social network Instagram as the preferred instrument of communication for the development of the project. At the beginning of November 2024, @novataxlab account on Instagram had 574 followers and 155 posts were shared. Building a knowledge path, four categories of information to be transmitted were created, each directed at different purposes, but all intended at creating a connection with the project and sparking interest in being a follower of the Instagram account: "Did you know"; "Tax Tips"; "Fun Facts"; "Hot Topics". 2. BUILDING THE ROOTS OF AN EFFECTIVE NOVA TAX COMMUNITY The Knowledge Centre's vocation is to be open to society and tax professionals. It is not intended to be a Centre closed to dialogue, but rather to maximize the activation of this possibility. In compliance with the Centre's by-law, NOVA TAX RESEARCH LAB targets "to develop projects in the field of Tax Law, including projects of social interest" and "to promote scientific exchange between national and international institutions, researchers and professionals" (Article 2, number 1, a. and b.). During 2024, we sought to establish connections with expertise national practitioners, recognised for their merit and boldness. The associations built up were with both senior and junior professionals since the research work and the vision of the Centre is intended to be plural and interoperable, as envisaged from the beginning. Following this ambition, the following were initiated: - NOVA Tax Gang Open Meetings - thinking taxes out loud: an action recently created by NOVA Tax Lab with the aim of providing discussions between the knowledge centre's researchers and recognised tax experts. We already held two NOVA Tax Gang Open Meetings, the first with Rogério Fernandes Ferreira and the second with Giorgio Beretta. - NOVA Tax Column: geared towards being a platform for practical reflection, encouraging the signalling and debate of subjects that deserve in-depth academic research. Thirty articles were published during this academic year. - Sharing Tax Thoughts: as an open space for our researchers to share meaningful questions and ideas that become thoughts a as an open space for our researchers to share meaningful questions and ideas that become thoughts after reading news, papers or while working. It is a format to promete to discussion and awareness





#### 2. Embedding the UN Global Compact in our internal strategies, policies and practices

In addition, we strive to 'walk the talk' by incorporating the values and principles of the UN Global Compact and the SDGs into the strategies, policies, and practices of NOVA School of Law in our daily life. In particular, a number initiatives to support and respect human rights and environmental standards within NOVA School of Law can be highlighted:

#### 2.1 Initiatives to Advance Human Rights

### 2.1.1. The promotion of Gender Equality within NOVA School of Law

In line with the policy of NOVA University, NOVA School of Law strives to be at the **forefront in the protection and advancement of gender equality.** In this respect, NOVA School of Law implements the ambitious <u>Gender Equality Plan 2021-2025</u> which has been adopted by NOVA University.

NOVA School of Law is also actively involved in NOVA's interdisciplinary PhD programme in Gender Studies and in major international research projects focusing on gender equality.

NOVA School of Law has also been creating bridges and partnering up with civil society organizations. As an illustrative example, the *Associação para o Planeamento da Família* (APF) has commissioned a report on the legal framework on conscientious objection in the area of abortion in Portugal that was presented during their 2024 annual meeting and that was cited during the auditions of the *Reunião Plenária do Conselho Nacional de Ética para as Ciências da Vida* on the new Portuguese abortion bill (Sept. 2024).

# 2.1.2. Diversity and Inclusion

NOVA School of Law adopts an **intersectional approach to protecting diversity and inclusion**. This approach is visible in both legal education, and legal research, but also within NOVA School of Law and is promoted by the recently created **Equality and Diversity Officer**, Professor Nausica Palazzo, who acts as a reference person for both the personnel and student body of the faculty on diversity matters.





Actions taken in the area of diversity, inclusion, and non-discrimination at NOVA School of Law include:

- The approval of the **Guidelines on Diversity, Inclusion, and Non-discrimination**. These guidelines encompass a tripartite objective:
  - a. Promoting inclusion and gender equality in institutional events such as conferences and seminars. By embracing flexible criteria, the guidelines enable organizers to assess whether the pursuit of gender balance and inclusivity has been integrated into the selection of invited speakers, without prescribing strict numerical benchmarks.
  - b. Incorporating, whenever feasible, a gender and inclusivity perspective into course syllabi. This entails applying such a perspective to subject selection, bibliographic references, and the broader development of course syllabi. Furthermore, NOVA School of Law is steadfastly committed to broadening the array of courses addressing themes within the domain of gender and inclusivity studies.
  - C. Ensuring that inclusion and gender equality are key considerations in the composition of internal committees, juries, panels, and other bodies.
- The organization of an **Inclusion Day** on an annual basis to reflect on the importance of creating a discrimination-free space at NOVA School of Law.
  - a. The 2024 Inclusion Day, held on November 11, 2024, included a set of student activities organized on campus regarding inclusion, and the Inclusion Talks, comprising two panels: the first one discussing inclusion in the private sector and the second discussing inclusion in the public sector. Both panels featured prominent speakers from the business sector (e.g. Microsoft), journalism, academia and the Portuguese Government (e.g. CIG and CITE). This event was organised in collaboration with the NOVA Centre for the Study of Gender, Family and the Law, the NOVA Centre on Business, Human Rights, and the Environment, the Inclusive Community Forum (ICF) and the Nova SBE Leadership for Impact Knowledge Centre.
- In the area of inclusion, the Commission for the Assessment and Monitoring of Students with Special Educational Needs was recently set up and the Student Support Office provided support to students with Special Educational Needs in order to guarantee equal opportunities and access.

In addition, NOVA School of Law is **collaborating with civil society organizations to promote awareness on diversity issues**. For example, it recently entered into a partnership with *Egalia*,





*ILGA Portugal* and *Associação para o Planeamento da Família* to carry out collaborative projects within the Jean Monnet Module on EU Family Law won by Professor Nausica Palazzo and funded by the European Commission.

We also actively promote diversity and inclusion through our research activities. For example, NOVA School of Law coordinated a research project funded by EEA in partnership with the Commission for Citizenship and Gender Equality (a Portuguese public body responsible for promoting and defending the fundamental principle of **equality between women and men**) entitled "The Multiversity Project – White Paper on Multiple and Intersectional Discrimination (EEAGRANTS/2022/SGS3-C1)". The project aimed to **construct a set of cohesive and scientifically grounded public policy recommendations based on multidisciplinary knowledge**. These recommendations sought to level and **harmonize antidiscrimination protections in Portugal**, considering sequential, additive, and intersectional multiple discrimination. The outcomes of this project are available <a href="here">here</a>.

In addition, in September 2024, **the NOVA Centre for the Study of Gender, Family, and the Law, was launched at NOVA School of Law**, opened by a keynote by the European Court of Human Rights justice *Ana Maria Guerra Martins*. NOVA GF Law is a knowledge hub that facilitates interdisciplinary research, public policy interventions, and strategic litigation in gender and family law. It comprises three lines of research:

- Family Law and Policy
- Equality Law
- Gender Religion and the Law

The NOVA Centre for the Study of Gender Family and the Law (NOVA GFLaw) participated in a project with the University of Berkeley and Pontificia Universidad Católica del Perú an *amicus curiae* before the Inter-American Commission on Human Rights to introduce the concept of intersectional discrimination into the Inter-American Convention system in a case involving the death of a disabled child from the Amazones who received poor health care services and education, thereby undergoing a form of intersectional discrimination (co-editors Nausica Palazzo, David Oppenheimer, Renato Constantino).

As an example of the work conducted in the area of gender equality, Professor Nausica Palazzo has focused her latest work on **gender and illiberalism** in Western societies undergoing democrating erosion, producing reflections on the ideological use of conservative gender and sexuality norms by illiberal actors. This led to an invited contribution on the *Routledge Handbook on Illiberalism*, the *Law and Ethics on Human Rights* review upon invitation, the George Washington University-based *Journal of Illiberalism Studies*. Journals like *The Review of Faith and International Affairs* hosted reflections on **how these developments play out at the international level (within the OSCE)**, where LGBTQ families are becoming increasingly





vulnerable due to the rejection by certain illiberal actors – e.g. in Russia – of the current "Western" human rights paradigm. In the edited collection *The Family in EU Law* by CUP, Palazzo examined the **response of the EU to gender backsliding**, and its attempts at protecting women and LGBTQ people as part of what Ursula von der Leyen calls the "European Way of Life", one that does not tolerate the stygmatization of LGBTQ families. These developments mark a pivotal moment for the EU, which explains why this type of research is destined to have more and more relevance.

Professor Jeff Redding and Professor Nausica Palazzo routinely co-author expert inputs for the United Nations (e.g. Report on Colonialism and SOGI (co-authored with Prof. Nogueira da Silva), and Thematic Report on Freedom of Religion or Belief (FoRB) and SOGI.

NOVA GFLaw researchers continuously contribute to legal and societal debates through publications and public outreach. Lúcia Pestana contributed to discussions on reproductive rights with her opinion piece in *Público* and an interview in *Notícias Magazine*, addressing challenges to abortion access. The Centre also participated in the 4th Cycle of the Fulbrighters Portugal Conferences, which featured our visiting Fulbright scholar Prof. Robin Wilson as the keynote speaker. Her talk, "Making Sense of the US Abortion Landscape after the Demise of Roe v. Wade," provided a critical analysis of the evolving legal and policy framework on abortion in the United States post-Dobbs. The past year, the Centre also saw significant research contributions. Tatiana Morais published in *Human Rights Quarterly* on "The Agency of Refugees and Asylum-Seeking Women in the Face of the Inability of States to Provide Protection Against Sexual and Gender-Based Violence." Oumaima Derfoufi was cited in the Report of the Independent Expert on Protection Against Violence and Discrimination Based on Sexual Orientation and Gender Identity. Additionally, Vânia Simões received the Impact Narrative Award at NOVA Science & Innovation Day for her research on obstetric violence, further highlighting the Centre's commitment to high-impact legal scholarship.

Furthermore, ANTÍGONA – Clinic For Equality and Discrimination Law, a Knowledge Center created within NOVA School of Law, carries out activities related to the **promotion of legal counselling, training and research in the areas of equality and discrimination law**.

In relation to our teaching activities relating to diversity and inclusion, NOVA School of Law has recently started to **diversify its course offering** in order to include a rich array of courses that cover diversity issues such as LGBTQ rights or intersectional discrimination. For instance, our Bachelor's degree now offers courses such as anti-discrimination Law, and Professor Nausica Palazzo was awarded a Jean Monnet Module in EU Family Law which includes a strong focus on LGBTQ families. At the master's level, we offer a cutting-edge course on comparative equality law that spans women's rights, LGBTQ rights, disability rights amongst the others and which is hosted by UC Berkeley Law, in partnership with 10 universities across the globe. We





also include issues of diversity and inclusion in our modules on Direito da Igualdade Social [Social Equality Law], and Direitos Fundamentais [Fundamental Rights].

Additionally, NOVA School of Law offers an **E-Course Intensive Program in Anti-Discrimination Law**, coordinated by Prof. Nausica Palazzo and Bianca Medeiros, which provides participants with a comprehensive understanding of discrimination law through a comparative and practice-oriented approach. The course features contributions from leading experts, including Aua Balde and David Oppenheimer, and covers key themes such as the history and evolution of anti-discrimination law, fundamental theories and challenges in the field, and litigation strategies in Europe but also in Inter-American and African human rights systems.

# 1.2. Initiatives to Advance the Protection of the Environment

#### 1.2.1. Waste management

NOVA School of Law is working on a **waste and management strategy in partnership with** *Electrão* (a Portuguese entity which assumes responsibility for waste management). Various points with containers have already been <u>installed</u> at NOVA University and NOVA School of Law is planning to install containers for electric waste and household appliances and light bulbs (in addition to the general recycling and battery container that are already available).

#### 1.2.2. Improving our energy efficiency

Over the last two years, measures have been implemented to make the faculty building more **energy efficient**, improving thermal and lighting conditions. These measures include the replacement of lighting systems and the purchase of more energy-efficient appliances.

**Energy-saving taps** have been installed at NOVA School of Law. The **water** consumed at the faculty comes from the public network. The use of reusable mugs is recommended and have been offered to employees. The faculty provides a **water fountain** for the entire academic community.

The number of **recycling bins** in the faculty building has been increased and we have placed new bins in the outside atrium. Recycling of the waste generated has been encouraged throughout the community and is constantly being monitored.





NOVA School of Law has made a strong commitment to **reduce its paper consumption**, given the impact of paper and ink cartridge consumption on the environment. Electronic messaging (e-mail) is encouraged in the communication of circulars, invitations, books, documents and other internal and external matters. In addition, students' dissertations and PhD theses are delivered in electronic format. The possibility of exams being taken in digital format is being analysed, and next semester we will already have the first exam trials in this format.

In 2024 the faculty implemented a **home office day** for all employees, which significantly contributes to reducing greenhouse gas emission

#### Part III. Measurement of Outcomes

The impact of our research work and contributions to human rights and the protection of the environment were recognized and rewarded by **2 prizes** received by Professor Claire Bright in December 2024, at the NOVA Science & Innovation Day for the impact of her research and contribution to the field of Business and Human Rights, and in particular:

- an Honorary Mention at the Research Impact Narratives Challenge for the impact of her work on Business and Human Rights on key legislative and policy developments at national level in various European countries and in Africa, as well as at the European level.
- an Award in the "Publications with Impact" Category, rewarding the scientific publications with the highest Field-Weighted Citation Impact during the 2021-2023 for the Commentary that 2 members of the NOVA BHRE (Claire Bright and Céline da Graça Pires) wrote on Guiding Principle 18 of the UN Guiding Principles on Business and Human Rights on the identification and assessment of actual and potential adverse human rights risks.

In relation to our internal policies and practices, NOVA School of Law is **monitoring closely the gender diversity of our staff, students, and research outputs**. The data attest to the attention to a **remarkable presence of women in leadership positions** (3 deans in a row are women, and 2 out of 3 vice-deans are also women). In addition, women outnumber men as full professors and in NOVA School of Law staff management positions.

In addition, significant steps were taken in relation to diversity and inclusion and include, particularly, the **appointment of an officer in charge of equality and inclusion** (Professor Nausica Palazzo), the adoption of guidelines in the Pedagogical Council to account for worklife balance and family commitments.





We also monitor closely and strongly encourage the **contribution of each of our Professors to each of the SDGs through their research and teaching activities**. As of 2024, the faculty has mapped its training offer, its research, its scientific production and a large part of its activities according to the Sustainable Development Goals.

Other measurable outcomes can be seen in the **number of research projects that we are undertaking that promote the SDGs and the UN Global Compact Principles**. For the 2023-2024 period, these include, *inter alia*:
